The First Party (**HAZI A. K. KHAN COLLEGE**), an Affiliated Institute under University of Kalyani, governed by the UGC, is engaged in conferring General Degree to its Undergraduate students.

**AND WHEREAS**

The Second Party being desirous in,

**ARTICLE 1: OBJECTIVE**

### ARTICLE 3: VALIDITY OF THE AGREEMENT


This Agreement will be affected from the date of execution and shall be valid for three (03) years, unless sooner terminated, revoked or modified.

### ARTICLE 4: JURISDICTION

If the dispute is not settled out in Arbitration, then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.




