The First Party (HAZI A K KHAN COLLEGE), an Affiliated Institute under University of Kalyani, Governed by the UGC, is engaged in conferring General Degree Programme in Arts Faculty to its Undergraduate students.

AND WHEREAS

The Second Party being desirous in,

1. Disposal of waste products from the college
2. Conducting Seminars or workshops for the young aspirants
3. Providing Hands-on Training, if any to the students
4. Providing Placements if any, in varied capacity

ARTICLE 1: OBJECTIVE

General objective of this Memorandum of Understanding (MoU) is to motivate and facilitate collaborative activities between the two parties to:

ARTICLE 3: VALIDITY OF THE AGREEMENT

This Agreement will be affected from the date of execution and shall be valid for three (03) years, unless sooner terminated, revoked or modified.

Either party may terminate the agreement at any time producing prior notice of one month to the other party.

ARTICLE 4: JURISDICTION


That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996. If the dispute is not settled out in Arbitration, then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.
