The First Party (HAZI A K KHAN COLLEGE), an Affiliated Institute under University of Kalyani, Governed by the UGC, is engaged in conferring General Degree to its Undergraduate students.

AND WHEREAS

The Second Party being desirous in,

1. Arranging Skill Development Programmes on Construction
2. Conducting Seminars or workshops for the aspirants in related Fields
3. Providing Placement

#### ARTICLE 1: OBJECTIVE

General objective of this Memorandum of Understanding (MoU) is to motivate and facilitate collaborative activities between the two parties to:

1. Involve college students in several Skill Development Programmes on Garment Industry
2. Motivate college students in participating in different seminars or Workshops in related area
3. Provide placement to students of the college in related fields.

#### ARTICLE 2: RESPONSIBILITY

The First Party will extend cooperation to the Second Party in

2. Allowing students to participate in seminars or workshops conducted by the Second Party
3. Providing necessary arrangements in the college to host related programme
4. Arranging exhibition of related products, if any

The Second Party will extend cooperation to the First Party in

1. Involving students of the college in several Skills related to Garment Industry
2. Motivating students in participating in several Workshops, Seminars
3. Providing employments for the students of the college in related fields
4. Arranging exhibition in collaborative manner
5. Focus on publicity and selling of related products made by this college students

### ARTICLE 3: VALIDITY OF THE AGREEMENT

This Agreement will be affected from the date of execution of the MoU and shall be valid for three (03) years, unless sooner terminated, revoked or modified.

Either party may terminate the agreement at any time producing prior notice of one month to the other party.

### ARTICLE 4: JURISDICTION

That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996. If the dispute is not settled out in Arbitration, then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.
