AND

M/s. AISAR ALI, Proprietor of a Powerloom Organisation with its office at Rejlapara, P.O. Hariharpara, Dist. Murshidabad, WB, Pin-742166, hereinafter referred to as M/s. AISAR ALI and represented by its Proprietor, referred to as SECOND PARTY.

The First Party (HAZI A K KHAN COLLEGE), an Affiliated Institute under University of Kalyani, Governed by the UGC, is engaged in conferring General Degree to its Undergraduate students.

AND WHEREAS

The Second Party being desirous in,

1. Arranging Skill Development Programmes on production and marketing of Indigenous Towel (*Gamchha*)
2. Provide Hand-on Training on production of Indigenous Towel (*Gamchha*)
3. Providing Placement to this Small Scale Industry

ARTICLE 1: OBJECTIVE

General objective of this Memorandum of Understanding (MoU) is to motivate and facilitate collaborative activities between the two parties to:

1. Involve college students in weaving indigenous towel (*Gamchha*)
2. Motivate college students to participate in Workshops in related area
3. Providing placement to students of the college in related fields.

ARTICLE 2: RESPONSIBILITY

The First Party will extend cooperation to the Second Party in

1. Allowing students to participate in Hand-on training programmes conducted by the Second Party
2. Allowing students to participate in workshops conducted by the Second Party
3. Providing necessary arrangements in the college to conduct Hand-on training by the Second Party

The Second Party will extend cooperation to the First Party in

1. Involving students of the college in weaving Skills
2. Motivating students in participating in several Workshops in related field
3. Providing placement for the students of the college in related fields

ARTICLE 3: VALIDITY OF THE AGREEMENT

This Agreement will be affected from the date of execution and shall be valid for three (03) years, unless sooner terminated, revoked or modified.

Either party may terminate the agreement at any time producing prior notice of one month to the other party.

ARTICLE 4: JURISDICTION

That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996.


