Objectives of the Seminar:

Consumer Protection Act of 1986 was passed to safeguard customers' rights, but as time went on, it became clear that the Act didn't cover issues like product liability, consumer contracts made with service providers or the manufacturers or the e-commerce industry. In order to fill the gaps in the Act of 1986, Parliament passes The Consumer Protection Act in 2019 which aims to provide a more comprehensive and robust mechanism to safeguard and strengthen the interests of consumers. The primary objective of the seminar was to spread awareness on the consumer rights and how consumers can be benefitted from these laws.

Brief Description:

The seminar began with the lighting of the lamp, followed by a welcome address from Dr. Goutam Kumar Ghosh, patron of the seminar and Principal of Hazi A. K. Khan College. He emphasized the significance of consumer awareness in today's world. The Resource Person, Somprakash Bhattacharya spoke about the Consumer Protection Act of 1986, its history, and the amendments made to it in the new law of 2019. He discussed the role of his office in creating awareness about consumer rights through various events. Md. Jasimuddin Mandal, Deputy Assistant Director Consumer Affairs and Fair Business Practices, Murshidabad Regional Office presented his ideas on different aspects of consumer protection and consumer rights, status of Educational Institutions under Consumer Protection Act, Healthcare Sector and Consumer Rights, Rural Consumer Awareness, Energy and Environment, Functioning of Judicial and Quasi-judicial Courts under Consumer Protection Act. Koushik Baral Consumer Welfare Officer of Consumer Affairs and Fair Business Practices, Murshidabad Regional Office spoke about ways and means of consumer protections, different consumer organisations and legislative measures to consumer protection. Soumyashri Saha, Food Safety Officer, Berhampore Sub-Division spoke about the Food Safety and Standards Act to protect consumers from unsafe food through formulation of science-based standards and their enforcement through analysis of food and market surveillance.

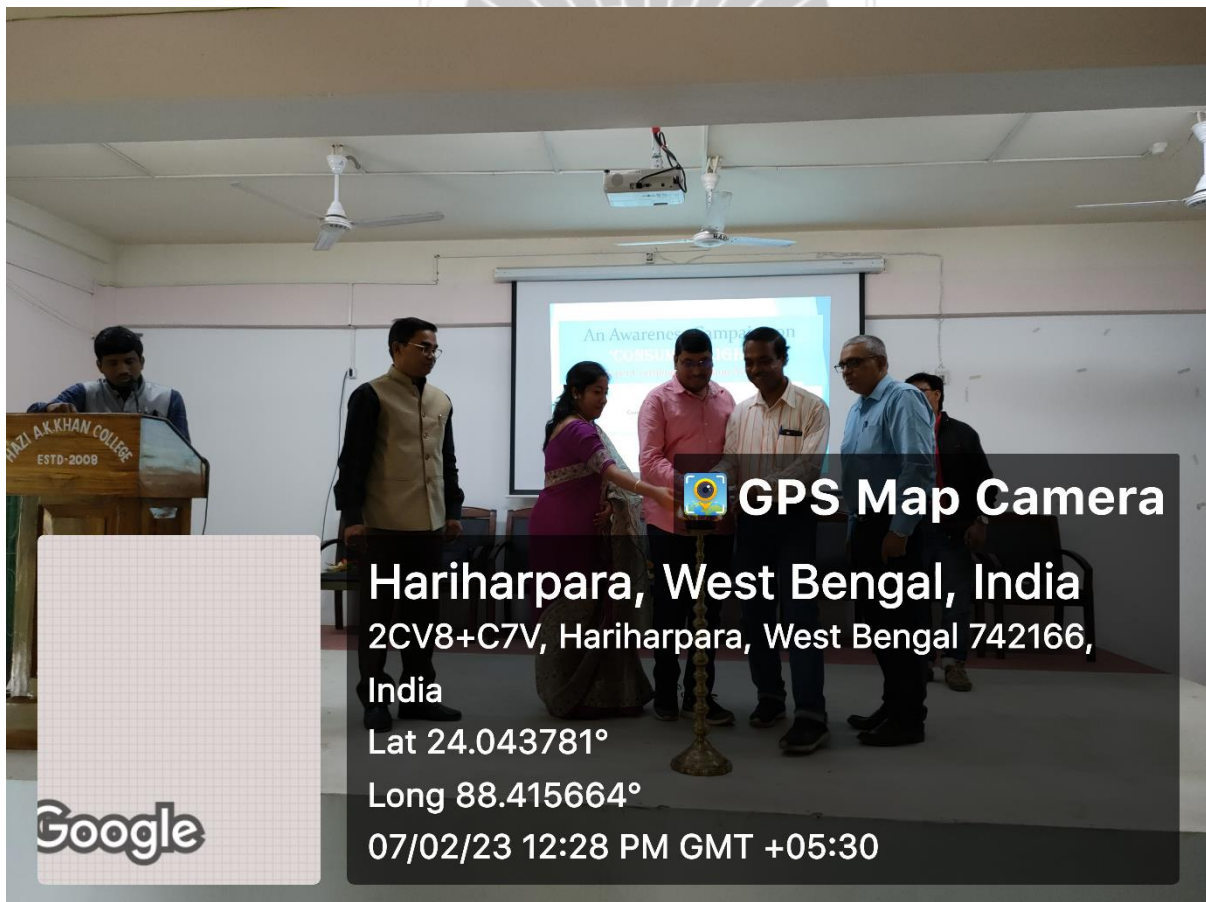
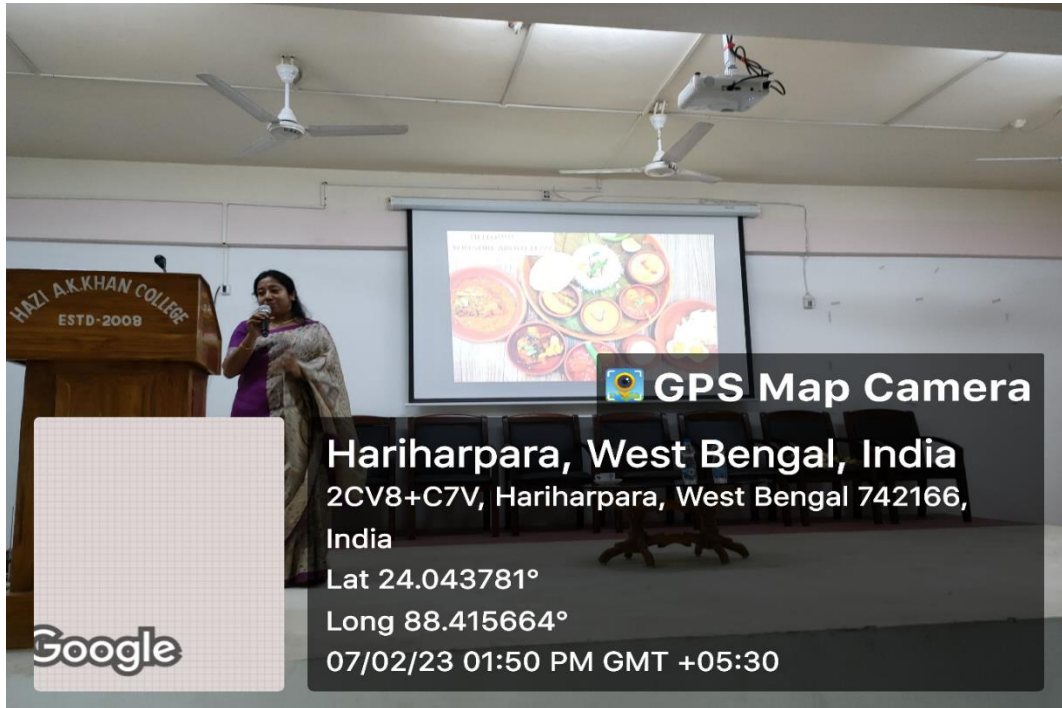
