Qualitative analysis of Criterion 1

Hazi A. K. Khan College is a grants-in-aid State Government sponsored College situated at Hariharpara, a rural block in Murshidabad district in West Bengal, catering to the higher educational needs of the area. The college was established in 2008 with the vision of providing higher education opportunities to the local population, particularly girls, who previously had limited access to further education.

The college is affiliated to University of Kalyani and is recognized under section 2f by UGC in 2023. Its purely a rural college. Over the years the college has consolidated its position as a premier academic institution in the vicinity. Presently the college has 10 departments out of which 09 major courses and 10 minor courses. The college offers various add-on courses to enhance students' career prospects. It also offers certificate courses on basic computer training, Yoga, Spoken English, Tailoring and self-defence for women.

The college has developed significant infrastructure development, including the addition of a well-architected annexed building funded by the Department of Minority Affairs, Government of West Bengal. The college features modern amenities such as theory classrooms, laboratories, ICT-enabled classrooms, Virtual classroom cum conference room, Multi Gymnasium, Departmental Library, Seminar Hall, Hygienic Canteen (staff and student separately) and separate common rooms for female and male students, parking areas, Sanitary Napkin Vending Machine and gender segregated hygienic wash room, Arsenic-free water supply.

The digitized library at Hazi A. K. Khan College boasts a good collection of books, journals, and e-resources, catering to the academic needs of students and faculty alike. The Online Public Access Catalogue (OPAC) facilitates easy navigation and access to resources. However, the post of Librarian to be filled on priority basis.

Hazi A. K. Khan College offers 07 Honours Courses and 10 programme courses under the Choice Based Credit System (CBCS introduced from 2018-2019 academic session), 09 Major Courses and 10 Minor Courses under National Education Policy (NEP introduced from 2023-2024 academic session). Continuous Internal Evaluation is conducted by the departments.

The College offers 38 Add-on Courses and Certificate Courses in last 5 years. These Courses with the

objective of developing some employable skills have well-framed syllabi beyond the purview of the existing syllabus of The University of Kalyani and have attracted students in large numbers.

The Institution skillfully integrates issues of Professional Ethics, Gender, Human Values and

Environmental Sustainability to help students cope with the challenges of modern living. The crosscutting issues of professional ethics, gender, human values, environment and sustainability are well integrated, assimilated and reflected in the existing curriculum with the aim of its enrichment. Total 636 students have undertaken project works under various departments of the college during 2022-2023 academic session.

It is observed that the College takes Feedback from various stakeholders like students, teachers, employers and alumni. But it needs to be strengthened further.

Qualitative analysis of Criterion 2

The College follows a transparent online Admission process following the guidelines and Reservation policies of Government and University. The present student-teacher ratio of the college is 133.36. The College is striving to increase Students-Teacher ratio by incorporating more faculties.

The College effectively stresses Experiential, Participative and Problem-solving Teaching-Learning methodologies by conducting practical classes, projects and dissertations, field trips, seminars, workshops, hands-on trainings, add-on and certificate courses. Community engagement, extension activities, students' seminars, debates, competitions and other co-curricular activities assist in knowledge gaining of students. College has adopted various — ICT-based methods for teaching-learning, including Power Point Presentation by Teachers & Students, Use of Online Platform like, ICT-enabled classrooms, Google Meet, Zoom etc. Online Feedback System, KOHA, N-LIST subscription, OPAC, and e-resources. Faculty members are qualified with NET/SLET/Ph.D. degrees.

The College conducts Internal and External examinations as per regulations of the University of Kalyani. It maintains a robust Internal Assessment mechanism monitored centrally by the Examination subcommittee. The college has conducted internal and external examination in online mode during the pandemic. Beside this the college conducts continuous evaluation throughout the year by taking class test, quiz, MCQ Test, debate etc.

Students can register their Examination-oriented grievances through Departments, Grievance Redressal Committee, Principal's office, Examination sub-committees, Online grievance portal which are resolved at college level.

The POs, and COs of all the programs and courses have been designed meticulously by the Departments. They have been shared with the students through college website, classroom interactions etc. The evaluation of Attainment of Outcomes is conducted through mechanisms like Results analysis, Attainment Portal score, Department meetings, Higher education progression, and Placement records. The College has healthy Examination Pass percentage hovering above the 94.18% mark over the last 5 years. The college students have also emerged topper at University level in various courses.

The faculty also participates in national and international seminars and have presented research papers.

Faculty development programmes (FDPs), Orientation and Refresher courses are also attended by the faculty members.

College has MoUs, Linkages and Collaboration with institutions and industries for faculty research, students participation and for carrying out reach activities. Collaborative initiatives have also been taken at college level by involving teachers and students. Extension activities have been given importance with focus on environmental awareness and sustainability, health and sanitation, women empowerment etc. over 40 extension activities and out reach programmes have been conducted by NSS volunteers and students in the areas. Community support like blood donation, food distribution, fund raising for flood victims and under civil awareness activities like voter awareness programmes, Har Ghar Tiranga and other initiatives are taken by the college.

Colleges has established its own power-loom for producing *gamcha* (towel) as this area has strong resources of jute plant and other *agro-based* materials. College is planning to promote more Skill developments programmes in the region.

There are 29 classrooms, 03 smart class rooms, 01 virtual class cum conference room, geography laboratory, seminar hall, separate IQAC room, departmental rooms, teaching staff rooms, girls common rooms with vending machine facility, child care room for female married students, boys common room, small play area, gymnasium etc. its pertinent to note that college has adequate number of ladies and gents toilets for students and staff members.

Yoga room, Self Defense room, Rain Water harvesting, Solar panel, Tailoring room are other prominent existing facilities at college.

The college takes up its developmental, repair and maintenance with the help of developmental fee. Budget

and financial support from state government's Minority department had been utilized for constructing new building and developing all required facilities with proper infrastructures. There are adequate number of Computers at various places for students, teachers and staff. More computer is to be added in library in future.

The college is fully Wi-fi with LAN connectivity at work. The Library Infrastructure is good with 8000 plus books, periodicals, newspapers, magazines E-Books/ E-Journal access facilities. KOHA has been installed and functional in Library. The Learning Resources (OER) are adequate at college.

Its remarkable to note that maximum students (over 98%) are getting one or the other scholarship like post matric scholarship, talent support scholarship, merit cum means for minority, merit cim means for non-minority, OBC/ SC/ ST scholarship etc. College encourages meritorious students through various programmes. This is very remarkable as the College is located in rural area and such financial supports are very helpful to students. College should initiate to start new programmes in Science and Commerce streams.
